Nearby Attractions

Concord Point Lighthouse

One of the oldest lighthouses in continual use on the East Coast. Spectacular views of the Chesapeake Bay.

Ripken Stadium

Home of the Aberdeen Ironbirds baseball team and the Ripken museum celebrating the baseball life of the Ripken family.

Rocks State Park

850-acre park featuring "The King and Queen Seats" rock formation and The Falling Branch waterfall, Maryland's second highest vertical falls.

Gunpowder Falls State Park

Gunpowder Falls State Park is a public recreation area comprising six non-contiguous areas covering 18,000 acres in northeastern Baltimore County and western Harford County, Maryland.

Susquehanna State Park

Features the Rock Run Grist Mill built in 1794, the New Jersey Toll House, and the Archer Mansion.

Directions to Edgewood Area of APG (South)

From Baltimore:


- I-95 North to Exit 77A (MD Route 24 South).
- Proceed approximately 4 miles to the Edgewood Area gate.

From Delaware:

- I-95 South to Exit 77A (MD Route 24 South).
- Proceed approximately 4 miles to the Edgewood Area gate.

From BWI Airport:

- I-195 West
- Exit 2A, MD 295 North (Balti-Wash Parkway) toward 1-695 Baltimore. Take I-895 Harbor Tunnel Exit.
- I-895 Harbor Tunnel merges with I-95 North. I-95 North to Exit 77A (MD Route 24 South).
- Proceed approximately 4 miles to the Edgewood Area gate.



Directions to USAMRICD

From Gate to Building E2900:

- Turn left at first traffic light onto Magnolia Rd.
- · Follow Magnolia Rd. (becomes Ricketts Point Rd.) around airfield.
- USAMRICD is on your left; parking is in the front of the building.

Entrance to APG

Visitors **with** a valid Government ID (CAC or other ID) may stop at the gate entrance and present guard with ID.

Visitors **without** a valid Government ID (CAC or other ID) need to have a visitors pass. To obtain one, stop at the Visitors Building on the right and present a valid photo ID and car registration at the desk.

Note All vehicles are subject to inspection. No cameras or photography is permitted at any gates. Visitors must use only hands-free phones while driving on APG.

Citizenship Requirements

Only U.S. citizens are permitted area access without Foreign Disclosure approval (minimum of 2 weeks notice is required for processing). Dual citizens are considered foreign nationals.

Security Requirements

Visitors should contact their USAMRICD point of contact at least 48 hours prior to arrival.
